

Training Report on "Biodiversity, Biodiversity Conservation & Sustainable Development" for Other Stakeholders

1.0 Introduction:

As per the mandate of the Ministry of Environment, Forest & Climate Change, Government of India, the training programme on 'Biodiversity, Biodiversity Conservation & Sustainable Development" for other stakeholders was organized at Institute of Forest Biodiversity (ICFRE), Hyderabad, from 24th to 25th February 2022 to raise awareness of Biodiversity Management Committee (BMC) from Medak, Medchal and Sangareddy districts. Owing to the rural background of stakeholders and internet connectivity issues raised by them the training was conducted in a hybrid mode. One resource person and some participants joined online while others were present at the Venue physically. The course co-ordinator Dr. S. Pattanaik, Scientist-F, welcomed the trainees, informed them about the host institution and briefly outlined of the purpose of the programme. This was followed by address by Shri. E. Venkat Reddy, IFS, Head Extension and Dr. Ratnaker Jauhari, IFS, Director, Institute of Forest Biodiversity, Hyderabad. Dr. Ratnaker Jauhari wished the trainees a wonderful learning experience during the course of the training. The chief guest of the programme Sri. Kalicharan S. Khartade, IAS, Secretary, Telangana State Biodiversity Board inaugurated the programme online and expressed that the training will be useful to all the BMC members.

The objective of the programme was to raise awareness of stakeholders on basic concepts on Biodiversity, value and importance of Biodiversity for sustainable development, Species diversity, *In-situ*, *Ex-situ* and *Circa situm* approaches of conserving biodiversity, Ecosystem diversity and Ecosystem services, Insect diversity and sustainable management of insects pests and Peoples Biodiversity Register. To meet this objective, the training was delivered through seven classroom sessions and one field visit. The schedule of the programme is appended in Appendix II

2.0 Classroom Sessions:

The classroom sessions covered the following aspects of Biodiversity Conservation and Sustainable Development. The sessions were handled by three external and four internal resource persons from Institute of Forest Biodiversity. A brief biodata and contact details of the resource persons are appended in Appendix III.

- 1) Basic concepts on biodiversity, Value and importance of Biodiversity for sustainable development economic value, environmental value, ecosystem services and resilience, social value, cultural value, medicinal value, scientific value, etc. by Dr. G. R. S. Reddy, Scientist G (Retd.), IFB Hyderabad
- 2) Ecosystem diversity and ecosystem services by Smt. Bharati Patel, Scientist B, IFB, Hyderabad.
- 3) *In-situ* and *Ex-situ* approach of conserving biodiversity by Dr. S. Pattanaik, Scientist F, IFB, Hyderabad.
- 4) Role of Agroforestry in *Circa situm* conservation of biodiversity by Dr. Madhavi Lata, Professor, PJTSAU.
- 5) Species diversity the cornerstone of biodiversity by Prof. V. S. Raju (Retd.), Kakatiya University, Warangal.
- 6) Peoples Biodiversity Register Drafting methodology, importance etc. by Shri. E. Manikanta Reddy, Technician, IFB, Hyderabad.
- 7) Insect diversity and sustainable management of insect pests in forest nurseries and plantations Dr. M. Deepa, Scientist D, IFB, Hyderabad.

3.0 Field Visit:

During the field visit the stakeholders visited the gene conservation stand of *Pterocarpus santalinus* located inside the campus of Institute of Forest Biodiversity, Hyderabad. During the visit, the trainees were exposed to the purpose of gene conservation stand, the sampling methodology adopted for collection of genetic material, the nursery technique, the plantation establishment technique and planting design adopted.

4.0 Composition of Trainees:




Figure 1: Trainee composition by gender

Altogether twenty-six trainees belonging to different panchayats participated in the training programme. These included Sarpanch, Secretary, Bill Collector etc. Of these, four trainees (15%) were females and twenty-two trainees (85%) were males (Figure 1). A detailed list of stakeholders along with their affiliation and communication details is appended in Appendix I.

5.0 Feedback of Trainees:




Figure 2: How was the training content?

A valedictory function was held on second day of the programme after completion of all classroom sessions and field visit. All trainees were requested to give their oral aswell-as written feedback (Appendix IV) for further improvement of the training programme. The trainees were requested to rate the programme on nine parameters. The responses of trainees to these nine parameters are depicted below (Figure 2 to Figure 10). Overall, 54 % trainees rated the training as Excellent, 8% as Very Good and 38% as Good (Figure 9). About 62% trainees felt that the training will be very useful and 38% trainees felt as useful (Figure 10).




Figure 3: Was enough time given on each topic covered?




Figure 4: How do you rate the resource persons?




Figure 5: What is your preferred mode of training delivery?




Figure 6: How do you rate the field visit?




Figure 7: How do you like the venue arrangements?




Figure 8: How do you like the food arrangements?




Figure 9: Overall, how do you rate the programme?




Figure 10: How useful will the training be in your profession?

5.1 Suggestions emerging from the feedback:

- Institute should organize the training classes in local language (Telugu).
- > The training should be organized on regular basis, in every quarter of the year.
- ➤ Measures to be taken to cover a greater number of participants from different villages.
- Awareness should be raised in rural areas, training to be conducted in village(s) for more active participation and publicity.
- Field visit/Field exposure need to be given more time.
- ➤ All sessions to be conducted in offline mode.
- Duration of the training programme to be increased to one week.

After the feedback session, all trainees were provided with a participation certificate. The programme was concluded with vote of thanks by Shri. E. Venkat Reddy, IFS, Head Extension. 
